In order to ensure that the application is delivered directly to the related unit, the statement "Information Request Under the Law on the Protection of Personal Data" must be found on the envelope in physical applications or in the subject line of the electronic mail in applications by e-mail.

Applications to be made within the framework of the second paragraph of Article 4 of the Communique must be in Turkish.

Your application shall be promptly reviewed by Northern Marmara Highway and answered in accordance with the provisions of the LPPD and the Communique within 30 (thirty) days as of the date of receipt by Northern Marmara Highway. The relevant reply shall be communicated to you in writing or electronically.

While Northern Marmara Highway requests no fees with respect to applications as a general rule, the fees determined by the Board may be charged if the process requires additional costs.


